THESE PROGRAMS INCLUDE ACCLAIMED EDUCATION PROGRAMS COLLECTIVELY KNOWN AS MUSE (MUSIC FOR EXCELLENCE), COMPRISED OF YOUNG PEOPLE'S CONCERTS, ORCHESTRA ENSEMBLES, IN-SCHOOL MUSIC LESSONS AND MENTORING, AND REGULAR SCHOOL VISITS BY MUSICIANS.
